Bishop's Welcome

Beloved Delegates of the Episcopal Church in Minnesota,

I cannot begin to tell you how excited I am to be joining you this fall in Rochester for my first in-person diocesan Convention as your Bishop. It has been a long, rocky, steep two and a half years, and I am parched, thirsting for the kinds of connection and joy that can only come from being together, incarnate beings sharing space, sharing stories, and sharing meals. I imagine that many of you are feeling the same way.

It's appropriate, then, that the theme for this year's Convention is "Rooting in Jesus." Many of you have likely heard me talk about my love for the work of Suzanne Simard, whose research has illuminated the profound ways that trees are connected with one another—communicating, sharing resources, and protecting and nurturing the whole vast diversity of the forest. Like those trees, each faith community in our diocese is profoundly connected to its neighbors near and far. Like those trees, we are connected through our roots, which reach deep into our common soil: the way of Jesus.

Rooting in Jesus means inviting every single Minnesota Episcopalian to dig into discipleship, drawing spiritual sustenance from our ancient traditions: daily prayer, dwelling in scripture, building community with the poor and marginalized, and sharing life deeply together. At Convention, we'll hear stories of those who have experimented with these practices and what fruit those practices have borne; we'll share individual and communal practices to help you root in Jesus that you can take back to your faith communities; we'll worship, eat, and celebtrate together; and we'll prayerfully undertake the business of the church, asking the Holy Spirit to root us more deeply in Jesus for the flourishing of the church in the years to come.

I am grateful to each one of you for answering the call to serve as a delegate to this Convention. In a real and concrete way, the ministry of serving as a delegate asks you both to honor and maintain the institutional structures we have inherited, and to courageously hear the whispers of the Holy Spirit as She coaxes forth the church that is to come. It is a delicate balance, and your ministry is a gift to the whole diocese.

Parking

Voting



At the opening of each annual meeting of the ECMN Convention (herein referred to as Convention), Standing Rules of Order are presented for adoption by the Convention. The following Rules of Order, revised in September 2018, are presented for adoption at this Convention.

- 1. The Chair may require that only accredited Delegates are seated within the Delegate area.
- 2. Any attendee granted a Voice who desires to address the Convention must do so from one of the microphones provided on the Convention floor. The Chair shall rule out of order anyone who attempts to address the Convention from other than a microphone provided for that purpose. When recognized by the Chair, the speaker will identify himself or herself by name, faith community, and city. Unless determined otherwise by the convention, speeches or presentations from the floor are limited to two minutes each, subject to the Chair's sole discretion to allow for additional time.
- 3. When a question is under consideration, no motion shall be received unless the purpose of the motion is to:
- a. lay it upon the table,
- b. postpone it to a certain time,
- c. postpone it indefinitely,
- d. commit it,
- e. amend it, or
- f. divide it.

Motions for any of these purposes shall have precedence in the order named. The motion to lay upon the table, and to adjourn, shall always be in order and shall be put without debate.

4. No motion shall be debated, or shall be considered as being before the Convention, unless seconded and, if required, presented in writing. When anything other than a routine motion is made by a Delegate, in the interest of clarity, a written copy of the motion is to be handed to the Secretary of Convention for the record.

- 5. Any of the following who are not already elected Delegates to the annual meeting of the Convention or otherwise provided with a seat at the same shall be admitted to the sittings of the Convention:
- a. all Clergy of the Protestant Episcopal Church, and of the Church in full communion with the same;
- b. Candidates for Holy Orders in the Episcopal Church in Minnesota;
- c. members of the Council;
- d. lay members of the Standing Committee;
- e. lay members of the Trustees; and
- f. President and Vice President (or Senior Warden and Junior Warden, as the case may be) of the Vestry or Bishop's Committee of a Church in which the Convention is held.

Upon admission of these persons to the sittings of the Convention, their names shall be entered on the register of those attending.

- 6. Voting by orders shall be done in accordance with Chapter 7-B of the Constitution as amended and adopted by the 1998 Convention.
- 7. The matters to come before the Convention shall include only those items indicated on the Agenda, as adopted at the opening of the Convention.
- 8. When procedure is not otherwise covered by the Constitution, Canons, or Standing Rules of Order, then Robert's Rules of Order Newly Revised (12th Edition) shall control.
- 9. In addition to any nominations for elected office contained in the Convention Booklet distributed prior to Convention, nominations may be made from the floor of Convention for any election that will take place at the Convention. Nominations from the floor follow the following procedure:

- a. Prior to any election, the Chair shall open the floor for additional nominations;
- b. Nominations may be made by any person in attendance who has been granted a Voice at Convention, and must be made from one of the provided microphones;
- c. Nominations do not require a second, but the person nominated must consent to serve if elected;
- d. Persons are allowed to nominate themselves should they wish to do so.
- 10. In all elections for which balloting is the determined method of selection, all nominees shall be listed on the first ballot. Any and all subsequent ballots shall contain no more than twice as many names for consideration as there are vacancies remaining to be filled, with nominees who received the least number of votes on the preceding ballot being removed from consideration until only the proper number of nominees remain. The only exception to this rule shall be that when the last nominee eligible to remain on the ballot was tied on the preceding ballot with one or more other nominees, all those tied for the last position on the ballot shall be listed on the ballot.
- 11. In the event that Convention is electing persons to any Office for terms of differing lengths, Delegates shall vote for the exact number of vacancies (of any length). The candidate receiving the most votes shall be elected to the longest term, the candidate receiving the second-most votes shall be elected to the second-longest term, and continuing in such manner until all vacancies have been filled. In the event of a tie, term lengths will be determined by drawing lots. Notwithstanding the provisions of this Rule, no candidate who does not receive at least one vote (or a higher number prescribed by Constitution, Canon, Standing Rule of Order, or will of Convention) shall be deemed elected to any post.
- 12. When General Convention Deputies and Alternates are elected at the same annual meeting of the Convention, election of Deputies and Alternates will occur on a single ballot. The ballot will list all persons nominated in each order. The four candidates in each order receiving the most votes shall be elected as Deputies.

The four candidates in each order receiving the most votes other than those elected as Deputies shall be elected as Alternates. Notwithstanding the provisions of this Rule, no candidate who does not receive at least one vote (or a higher number prescribed by Constitution, Canon, Standing Rule of Order, or will of Convention) shall be deemed elected as a Deputy or Alternate.

- 13. None of the election procedures described in these Standing Rules of Order shall apply to the election of a Bishop Diocesan, Bishop Coadjutor or Bishop Suffragan. Such elections shall be conducted according to rules prescribed and adopted for that purpose.
- 14. Computer-assisted balloting may occur at the discretion of the Chair.
- 15. Resolutions that have not been submitted to the Secretary of Convention and the Committee on Constitution, Canons, and Resolutions for consideration may not be introduced at Convention. However, the Chair may, at his or her discretion, make an exception and entertain any resolution of the nature described above and recommend its introduction at Convention. If such recommendation is approved by a majority vote of the Convention, the resolution shall be received and considered by Convention.
- 16. Any of the following related to the annual Budget shall be out of order and shall not be considered or voted on by the Convention:
 - a. any motion to adopt a proposed budget that is not a balanced budget; b. any motion to adopt a proposed budget that does not provide for the E piscopal Church in Minnesota to fulfill its full obligation of support to the Episcopal Church; and/or
 - c. any motion to amend the proposed budget in any manner that results in budgeted expenses in excess of anticipated income in the ensuing fiscal year from the apportionment of Parishes and Missions and/or from other sources of Episcopal Church in Minnesota income.

2022 Consent Calendar

A consent calendar is a body of actions that are routinely administrative in nature, canonically required of the bishop each year, and are not viewed as controversial. As such, the following is presented by The Rt. Rev. Craig W. Loya for approval by Convention. At the time of consideration, the appropriate action is for someone to move to approve the appointments on the calendar on a courtesy basis. The calendar can then be approved by the Convention, or a member of the Convention may request to have any item taken up separately for whatever reason.





Narrative

Introduction

This diocesan budget, a financial statement of our mission, is built collaboratively by the Bishop, ECMN Missioners, ECMN Treasurer, the Joint Finance and Audit Committee, and Council. This document is intended to reflect the work the diocese is called to do and aligns us with our understanding of where God is calling us, and who God is calling us to be.

Last year, we restructured the financial statement to align with the four priorities outlined by the Bishop at ECMN Convention in 2020. Since that time, Justice, Vitality, Innovation, and Discipleship have truly come to direct and shape the work of the diocese and of each missioner.

At its core, our budget must be both stable enough to maintain the institutional structures that we have inherited and flexible enough to allow us to experiment with new ways of being church, spending our time, talent, and treasure to explore our way into becoming the church that God is calling into being.

This budget reflects several experiments we'll undertake as we seek new ways to support both the vitality of existing congregations and emerging worshiping communities and entrepreneurial leaders.

The State of the Finances

ECMN is financially healthy. Guided by the Financial Task Force—composed of the head of the Trustees, Council, and the ECMN Treasurer—and the Joint Finance and Audit Committee (JFAC), ECMN has been able to be both financially flexible and conservative. These groups helped the Bishop and Missioners adapt, plan for the future, and better support faith communities.

It was this conservative and responsive financial leadership that helped ECMN realize a \$270,000 budget surplus in the last fiscal year. Under the guidance of Council, that surplus has been redistributed directly to faith communities over the past six months.

These talented groups of leaders are also beginning the conversation about what faith community and diocesan finances will look like in the future. As the church changes and the role of the diocese shifts, the financial structures that undergird and support us will, necessarily, shift as well. This conversation is only just beginning, but it is incredibly important.

Narrative

The Numbers

What follows is a technical explanation of how the budget is structured, the rationale behind each budget category, and stories and examples of how this work has unfolded during the past year.

Triennial Roll-up

This is a high-level look at the revenue and expenses of the organization. Included is an overview of last year's numbers, a projection for 2022, and a look ahead at the budget categories over the next two years. Triennial budget forecasting helps us to imagine how each budget area can remain sustainable, even as we acknowledge that budgets can, should, and will change year to year.

In the Triennial Roll-up, you can see the aggregate expenses for each budget category. In the Operations Detail, you can find the breakdown of those expenses into personnel and program costs.

Revenue

There are three main sources of revenue for ECMN:

Mission and Ministry Support (MMS)

The funds that each faith community dedicates to supporting the diocese. Currently, the rates set by the Joint Finance and Audit Committee and approved by Convention for each faith community are either 13% or 11%, depending on the faith community's operating budget.

Endowed and Invested Funds

ECMN has been blessed with a healthy endowment, managed by the Trustees, in the Pooled Investment Fund. Each year, we pull from the earnings on those funds to support the work of the Diocese. We are in the second year of drawing slightly above the recommended 5% from our pooled and invested dollars, with the approval of both the Trustees and Council. This year we are drawing less than we did last year, in order to ensure that we can move that draw back to 5% after year three.

Program Revenue

Funds collected (usually as registration fees) to offset the cost of programs and events. Overall, revenue has been stable this past year.

Narrative

Expense

The expenses are broken up into six budget categories. These categories communicate the way our money is spent to support our work of discipleship, justice, innovation, and vitality.

Investment in Formation and Discipleship:

daily practices that help us follow Jesus as a whole way of life

The most important work of fostering strong disciples occurs at the faith community level. To support this work, the School for Formation nurtures lay and ordained leaders, and has created a safe and supportive environment for those on the "front lines" of ministry to learn our history and traditions, refine their ministry skills, and imagine, wonder, and faithfully innovate new ways of being church. The **Dean of Formation** oversees this work by ensuring that course offerings are relevant and high-quality, and by bringing together a cohort of engaged and passionate leaders to learn from and support one another not only during their formation but throughout their ministries, serving the diverse faith communities of ECMN. Though this missioner position is currently open, as our previous Dean answers the call to serve as rector of a Minneapolis faith community, the diocese remains committed to this foundational work of formation and discipleship.

Supporting this crucial work of fostering disciples also looks like the many retreats, camps, trips, and leadership opportunities available to all ECMN youth. We are excited to rebuild that vibrant and life-giving community as we slowly make our way out of the pandemic, under the leadership of our **Minister for Children and Youth**.

These missioners are also on the road, preaching, getting to know faith communities across the state, and supporting formation ministries for all ages in local faith communities.

In addition to the work of the Missioners, you'll also see line items in this budget category that support the day to day operations of the School for Formation, the Holy Orders process for those in formation for ordained ministry, and ECMN youth events. These budget allocations are partially offset by revenue streams like tuition and donations, which you'll see recorded at the top of the document.

Investment in Justice:

joining the Spirit in becoming the beloved community

This work is emerging, as we continue to discern how the diocese is called to best foster just practices and culture both within the institution of the diocese and in individual faith communities.

Since the departure of the **Missioner for Community Engagement**, the Bishop and other diocesan leaders have been engaged in deep listening to ensure that the next iteration of this role is well-positioned to support and lead the emerging work of seeking and nurturing justice, and particularly to support the diocese's multicultural and culturally-specific faith communities. These are faith communities that are predominantly comprised of parishioners not of European descent, who may speak a language other than English as their primary language, and who thus have not been well-served by the power structures in place historically and today, both within and outside of the institutional church. These thriving communities have much to teach the wider diocese about what the Beloved Community looks and feels like, and, as such, will be our best teachers as we continue to seek and foster justice here in ECMN. This budget holds the compensation from the Community Engagement role for that new and emerging position, which will be hired in early 2023.

The **Canon for the Department of Indian Work** (DIW) position has been streamlined in the past year. Previously, this position had been tasked with supporting multicultural and culturally-specific faith communities in addition to DIW congregations. In order to ensure that both of those groups of congregations are adequately supported, this work has been separated into these two different positions.

Additional changes in budget line items in this category include:

 Racial Justice and Healing Formation Support: This budget line item has existed under the title 'mission opportunity support' and 'priorities experiments' in previous years. The Racial Justice and Healing Commission has been tasked with building a curriculum that will be used by faith communities across the diocese to seek racial justice and reconciliation. This budget line item is shifting to support the development of that curriculum and its implementation in years to come.

- Ministry Support to Multicultural Faith Communities
 - New Latino Church Plant: this new line item, which had been used to support the compensation of a Spanish-speaking priest at Saint Nicholas, has shifted to follow that priest as he plants a new congregation.
 - Multicultural Ministries Support: additional funds have been added to this budget to provide support and resources to multicultural and culturally-specific faith communities. In the coming months, we'll begin work to envision and plan how those dollars will be best spent.

Investment in Vitality and Innovation:

joining the Spirit in new ways to proclaim and live out the gospel nurturing vital faith communities of every kind, in every place.

Within this budget category sits the work of creating, nurturing, and sustaining vital communities, providing concrete resources and support for congregational vitality, working with congregations during times of discernment and transition, and telling the stories of what God is doing in our lives.

The work of the **Canon for Vitality and Innovation** has been pivotal as we seek to live more fully into these priorities. This position visits congregations weekly; leads the Faithful Innovation process, which brings together lay leadership teams from faith communities across the diocese to learn practices that help foster deep discipleship and strengthen relationships with neighbors; and will develop and oversee a process to nurture entrepreneurial new expressions of church.

The **Canon for Ministry** works with faith communities across the diocese as they navigate transitions in clergy leadership and ministry models, face various challenges in their congregational life, and faithfully discern who God is calling them to be. This work involves deep listening and relationship-building, including lots of phone calls, time on the road, and vestry meetings.

The **Missioner for Communications** continues to play an important role in the work of innovation and vitality. Storytelling–vulnerably sharing our experiences of the Spirit at work in our lives and communities—is at the heart of all our efforts to connect more deeply to one another and to live more fully and authentically into who God is calling us to become.

Narrative

Centering communications in this category emphasizes that our communications platforms act as the nervous system for this Body, transmitting not just the information necessary to our functioning, but the vital stories that bring us into deeper relationship with one another and inspire collective creativity and innovation.

There are several new line items in the budget that fund new and emerging initiatives intended to better support faith communities and strengthen our connection to one another:

- *Archdeacons*: these dollars will be spent to reimburse the three archdeacons appointed by the Bishop for their mileage as they visit and support deacons in congregations around the state. These are non-stipendiary positions.
- Regional Deans: the Bishop will appoint two individuals to act as Regional Deans—one
 in the north, and one in the south. These funds will provide stipends for part-time clergy
 already serving congregations in those regions. The Deans will coordinate with and
 support faith leaders in the area.
- Ministry Companions: these dollars are used for stipends to support a group of lay and ordained leaders who act as consultants to faith communities. They have been trained by ECMN staff and are currently walking alongside faith communities going through times of transition, conflict, or facing other big questions.
- *Ministry Development:* this line item has historically funded many different ministry supports that will now be covered by the line items above.
- Events and Networks: we have added this line and subsequently eliminated several line items in the Infrastructure and Management section that went to funding specific events. Because we're continuing to experiment with how we gather people for formation, relationship-building, and peer learning, creating one budget line for events will allow us to be more flexible as we continue to try out different ways of gathering.
- Supporting New Expressions of Church: This is a new line item. The work of the Canon
 for Vitality and Innovation will focus on, among other things, helping ECMN develop a
 system to discern, develop, and support new expressions of church. We're building this
 work alongside the Episcopal Church, and these funds will go toward building that
 process and supporting those experiments.

Investment in Infrastructure and Management

Investment in our infrastructure and management makes up the largest portion of our budget, as these line items are the backbone that allow ECMN to function.

2023 Financial Statement of Mission Narrative

The work of the **Missioner for Networking** this year has been refining the diocese's practice for gathering, organizing, and retaining data in a way that fosters connection across the Body, and improving ECMN's capacity to plan future work in a data-informed way. Moving forward, this position will also include supporting the Trustees, and working with the Standing Committee and Trustees to support faith communities navigating property transactions.

The **Property Manager** position marks a shift away from a full-time Missioner for Administration role, with some of those responsibilities reallocated to other missioners. This part-time position includes managing 1101 W Broadway, which is owned by the Trustees and houses the offices of the Bishop and Missioners. The building is a vital asset, heavily used by ECMN faith communities and neighborhood organizations, initiatives, and community groups. The Property Manager also acts as office manager and finance and health benefits administrator.

The **Missioner for Finance** provides financial support and oversight for ECMN's finances, from day-to-day transactions to weighing in on large-scale investment strategies. The Missioner for Finance likewise works closely with both the Trustees and individual faith communities navigating financial complexities of all kinds. ECMN acts as the fiscal sponsor for new faith communities, of which there are currently three. The Missioner for Finance assists these new communities in creating bookkeeping systems and alleviates other financial record-keeping challenges.

In addition to the work of the Missioners included in this budget category, you'll also see office expenditures for 1101, along with budget line items for some of the major events that undergird our diocesan life.

Investment in the Episcopate

While the financial statement of mission as a whole is a reflection of the work of the Episcopate, this budget category directly expresses the work of the **Bishop of the Episcopal Church in Minnesota.**

The work of the Bishop is to be present, pastoral, and prophetic: present in faith communities across the diocese through visitations and events, pastoral for clergy and lay leaders providing ministry in their local contexts and to the system at large as each Minnesota Episcopalian seeks to follow Jesus more faithfully, and prophetic, continuing to speak into being the vision for who we are called to be.

While the Bishop's role is to help the diocese discern, articulate, and pursue a vision that aligns with how the Spirit is moving among us, the **Canon for Operations** plays the critical role of implementing that vision. The work of the Canon for Operations is to ensure that all areas of the organization have the resources they need to flourish. This work focuses on strategically implementing the vision of the diocese and helping to shape, organize, and monitor that work as it moves forward.

The **Missioner for the Bishop** makes it possible for the Bishop to do his work, including being present and available in the diocese. The complexity of demands on the Bishop's schedule and the multiplicity of the Bishop's responsibilities cannot be overstated. It is the work of the Missioner for the Bishop to navigate those complexities, and juggle those responsibilities, with proficiency and clarity, and with care and compassion for every member of ECMN.

Investment in the Episcopal Church

It's important that we name this line item separately, as it signifies our connectedness. We as ECMN are one body in 104 places across the state. Similarly, we are connected to the wider Episcopal Church and, through the Episcopal Church, to the global Anglican Communion. We offer the gifts that we have been given, and are, in turn, nourished, led, and connected to the wider body. Our ministry support payment is one expression of that connectedness.

Conclusion

In this particular moment in the life of the church, our goal is to construct a budget that is faithful to all that we are responsible for preserving as well as all that we are called to steward into being; to continue saying yes to all the new ways that we are called to faithfully follow Jesus while holding fast to the shared commitments and structures that remind us, again and again, that we can only do this good work together.

Report to Delegates from Constitutions, Canons & Resolutions Committee Regarding Proposed Amendments to the Canons of the Episcopal Church in Minnesota for Convention 2022

The Constitution, Canons & Resolution Committee ("CCR Committee") is organized under ECMN Canon 213, and is tasked with reviewing, recommending, and drafting proposed amendments and new provisions to the ECMN Constitution and Canons, as well as reviewing resolutions that have been submitted to the Secretary for consideration at least ninety (90) days prior to Convention in accordance with ECMN Canon 214.2.

With ECMN scheduled to host its first in-person Convention since February 2020, the CCR Committee met on August 4, 2022, to discuss proposed amendments to Canon (no amendments to the ECMN Constitution are being proposed at Convention 2022) and resolutions that had been received by the deadline established by ECMN Canon 214.2. The CCR Committee, on its own accord, proposes edits to the following ECMN Canons, which are more fully explained in the Convention Booklet:

Recognizing Good Courage Farm as an Episcopal-Affiliated Organization

Resolved that the Episcopal Church in Minnesota recognizes Good Courage Farm, a 501(c)3 nonprofit agrarian ministry in Hutchinson, as an Affiliated Organization under Canon 108.

Background:

As an agrarian ministry (housed on the regenerative farm owned by the Rev. Kerri Meyer, an Episcopal priest, and Dr. Jen Blecha, a scholar and professor of sustainable agricultural systems), Good Courage Farm provides opportunities for people to witness God's renewing love for all of Creation through the tending of soil, crops, animals, and human relationships. Using sustainable and regenerative methods, the farm grows healthful food for people while growing faithful disciples for Christ. Good Courage Farm offers spiritual enrichment and environmental education to people of all faiths and none. We gather in worship, fellowship, community-building, and labor as Christian partners in the larger faith-based food and agriculture movement, collaborating in restoring Creation while building a just food system that both honors our God of abundance and shows love for our neighbors. Embedded in the beauty, abundance and travail of farming, Good Courage offers hospitality and space for service, sacrament and sabbath.

Bishop Loya has given his blessing to establish Good Courage Farm as an unfolding collaboration with ECMN.

The Chancellor has reviewed the bylaws, and the Board of Directors operates with the expectation of affiliation with ECMN.

The Standing Committee reviewed and consented to Good Courage Farm being considered an Episcopal-Affiliated Organization at its meeting in September 2022.

Resolution Expressing Support for Reproductive Rights & Bodily Autonomy:

Whereas, The Episcopal Church believes parenthood "should be initiated only advisedly and in full accord with this understanding of the power to conceive and give birth which is bestowed by God" (1988-C047); and

Whereas, The Episcopal Church opposes any "executive or judicial action to abridge the right of a woman to reach an informed decision about the termination of pregnancy or that would limit the access of a woman to safe means of acting on her decision" (1994-A054); and

Whereas, The Episcopal Church maintains access to equitable health care, including reproductive health care and reproductive procedures, is "an integral part of a woman's struggle to assert her dignity and worth as a human being" (2018-D032); and

Whereas, The Episcopal Church believes "reproductive health procedures should be treated as all other medical procedures, and not singled out or omitted by or because of gender" (2018-D032); and

Whereas, The Episcopal Church recognizes that "access to abortion is a key element in preserving the health, independence, and autonomy of those who can bear children" (2020-D083); and

Whereas, it is the official position of the Episcopal Church that all of its members should be able to access abortion services and birth control with no restriction on movement, autonomy, type, or timing and that the protection of religious liberty extends to all members who may need or desire to access, utilize, aid others in the procurement of, or offer abortion services (2020-D083); and

Whereas, the Minnesota Supreme Court has unequivocally held that the right to privacy under Article I, Sections 2, 7, and 10 of the Constitution of the State of Minnesota encompasses a woman's right to decide to terminate her pregnancy and guarantees that the "difficult decision whether to obtain a therapeutic abortion will not be made by the government, but will be left to the woman and her doctor" (Doe v. Gomez, 542 N.W.2d 17 (Minn. 1995)); and

Whereas, on June 24, 2022, the Supreme Court of the United States issued its decision in Dobbs v. Jackson Women's Health Organization, overturning the constitutional right to abortion that was recognized by the Court in its 1973 decision in Roe v. Wade; and

Whereas, the Court's decision in Dobbs eliminates federal protections for abortion and leaves regulation of the issue to the states; and

Whereas, while the impact of the Court's decision in Dobbs will have ramifications across the county, that impact will be particularly acute for those who are impoverished or lack consistent access to health care services; now therefore it is

Resolved, that the Episcopal Church in Minnesota acknowledges the need for universal and equitable access to quality health care that allows for equal utilization for those with equal need; and be it further

Resolved, that the Episcopal Church in Minnesota, consistent with the position of The Episcopal Church, unequivocally opposes any legislative, executive, or judicial action on the part of local, state, or national governments that abridges the right of a woman to reach an informed decision about the termination of pregnancy or that would limit the access of a woman to safe means of acting on her decision.

Resolution Urging ECMN Faith Communities to Pray for Creation

Be it resolved that every worshiping community of the Episcopal Church in Minnesota be encouraged to observe an entire year of recalling our 'Vocation in Christ' (from now until Advent 2023) by offering the following prayer at parish gatherings and liturgies, in a timeline determined by each worshiping community's leadership. The prayer was formed from the House of Bishops "Mind of the House on Climate" from the 80th General Convention of the Episcopal Church, July 11, 2022.

O God, you are the source of all creation that sustains our life together. By caring for creation we accept our first vocation, reflecting your tender love and returning our love to you. Climate change and earth's degradation show that we crave and hoard what we do not need, deepening injustice and causing suffering for our most vulnerable neighbors and imperiling ourselves and one another. Yet you have baptized us into brilliant resurrection hope. Through that hope, teach us to love and persevere, and give us the courage to act, so that our bountiful earth can continue and we can know your beloved community. Amen.

Explanation:

The House of Bishops, at the 80th General Convention of the Episcopal Church, passed a statement with the House Deputies concurring: Expressing the Mind of the House on Climate and Our Vocation in Christ. This statement continues in the tradition of decades of statements, actions, and resolutions by General Convention that call, encourage, and provide for the church to make ever stronger response to climate change and environmental degradation.

Prayer is both the 'least' we can do in the sense of the common denominator of common prayer, and also the 'most' we can do, in the sense of connecting us to God the source of all life.

Committed common prayer unites the diversity of individual faith communities in ECMN. One size does not fit all for climate action. Response must be contextualized to be meaningful to all ECMN faith communities. The local natural ecosystem and community will require different actions in rural Western Minnesota parishes than in North Shore parishes; in downtown urban parishes than in small town valley parishes, in congregations than in schools and affiliates. By praying regularly about our call in creation and climate change in the words of our bishops, what God is calling us to will be weekly put in the mind of the local Episcopal community, which will respond in its unique way.

Resolution Urging ECMN Faith Communities to Pray for the Climate

Committed common prayer unites in the midst of the divisions in our country. Climate change is a real threat of frightening magnitude, clearly demonstrated by scientific consensus around the world. Yet the strident political divisions of our time and nation have co-opted this wide theological crisis and construed it as a narrow political one. Weekly praying this prayer will center this concern of all living humans in its true setting—our call by God to live in harmony with the earth and to daily respect the sustenance that it gives us and our promise of hope to realize the beloved community.

Committed common prayer enlivens the hearts of the faithful, honoring the ministry of the baptized. Praying this prayer weekly will invite a grassroots-up experience of ECMN, as each community's members respond to God and what their church can do in their community to respond to the climate crisis.
